### **GENERAL STATEMENT**

This internship position is responsible for supporting water efficient program services which include, but are not limited to, assisting with garden tasks, supporting various education and outreach tasks, and other landscape and irrigation tasks as assigned.

#### INTERN DUTIES AND RESPONSIBILITIES

- Supports upkeep of Northern Water's Conservation Gardens by performing regular landscape maintenance tasks such as weeding, pruning, planting, digging, and applying mulch.
- Assists with irrigation maintenance tasks as assigned.
- Willingness to operate power and handheld tools such as hedge trimmer, leaf blower, pruners, edgers, mowers, soil knife and others as assigned.
- Produce to-scale planting plans with mentor's guidance.
- Assists with creating and procuring signs for garden demonstrations.
- Supports garden tours and other outreach and educational efforts of the department.
- Supports Northern Water's overall mission and vision.
- Supports other water efficiency programs and duties as assigned.
