#### **GENERAL STATEMENT**

The Senior Water Quality Policy Specialist plays a critical role in monitoring water quality regulations and representing the organization in various regulatory and policy forums and workgroups. This role has a deep understanding of Northern Water's activities related to water quality matters, permits held by the organization, and compliance with regulatory requirements. This senior-level position requires extensive knowledge of water quality regulations, active participation in regulatory workgroups, and effective communication with regulatory agencies as well as internal and external stakeholders involved in water quality regulatory matters.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES**

- Monitors water quality regulations at the local, state, and federal levels.
- Develops, maintains, and strengthens relationships with state, regional, and federal water quality policy administrators and policy makers, and other water quality stakeholders.
- Participates in regulatory workgroups and committees organized by the Colorado Water Quality Control Division.
- Assists with preparation of testimony for Colorado Water Quality Rulemaking Hearings.
- Represents the organization with the Colorado Water Quality Forum, the Water Quality
  Committee of the Colorado Water Congress and any other relevant group involved in the
  coordination of water quality policy and regulatory matters.
- Represents the organization in discussions and negotiations related to water quality regulatory affairs, including meetings with regulatory agencies and stakeholder groups.
- Reviews regulatory and policy proposals relevant to water quality, including technical aspects, coordinate internal comments with staff, legal counsel, as governmental affairs representative as part of the public comment process.
- Monitors comments from other stakeholders and participates in discussions to advocate for the organization's interests.
- Attends hearings, meetings, and other regulatory events, and reports back on discussions, decisions, and potential impacts on the organization.

- Organizational skills, with the ability to manage and prioritize tasks effectively to meet deadlines and objectives.
- Collaboration skills, including the ability to work collaboratively with internal teams, external stakeholders, and regulatory agencies.
- Attention to detail, with a focus on accuracy and completeness in reviewing regulatory documents and preparing comments.

#### **Abilities**

- Navigate complex regulatory environments and effectively advocate for Northern Water's interests.
- Represent Northern Water professionally in regulatory meetings, hearings, and other forums.
- Adapt to changing priorities and respond effectively to emerging regulatory issues.
- Analyze and assess the potential impact of regulatory proposals on Northern Water and develop appropriate strategies in response.
- Stay informed about new developments in water quality regulations and apply this knowledge to support Northern Water's objectives.

## **PHYSICAL REQUIREMENTS**
